Due to safety concerns raised by the Lafayette County Sheriff's Department the following items are **NOT** allowed at the Pioneer Day festivities.....

- · No Alcohol,
- No Fire Crackers, Poppers, or any Explosive Devices.
- No by-products hard to clean (i.e. silly string, confetti, etc.)
- No Sling-Shots, Wrist Rockets or other human powered projectile weapons
- · No Pets. With the exception of Service Dogs\_

Security will be provided on Friday and Saturday during the event, for the convenience of our vendors. During the event, the Lafayette County Sheriff's Department will have a Rapid Deployment Center located in the park....

Deadline for Applications is September 30, 2019.

The State of Florida requires all vendors to have tax identification. You can obtain a temporary identification by contacting Florida Department of Revenue @ 386-758-0420.

Vendors can begin setting up on Friday. We ask that vendors do not begin break-down until 6:00 p.m.
