The Town Park will be open for set up, Friday Oct. 11, 2019. Vehicles will only be allowed in the park from 8 a.m. to 10 p.m. All vehicles must be out of the park by 10:00 p.m. Vendors can then bring in their vehicles after 6 p.m. on Saturday to break-down....

Due to safety concerns raised by the Lafayette County Sheriff's Department the following items are **NOT** allowed at the Pioneer Day festivities....

- No Alcohol,
- No Fire Crackers, Poppers, or any Explosive Devices.
- No by-products - hard to clean (i.e. silly string, confetti, etc.)
- No Sling-Shots, Wrist Rockets or other human powered projectile weapons
- No Pets. With the exception of Service Dogs...

Security will be provided on Friday and Saturday during the event, for the convenience of our vendors. During the event, the Lafayette County Sheriff's Department will have a Rapid Deployment Center located in the park....

Deadline for Applications is September 30, 2019.

The State of Florida requires all vendors to have tax identification. You can obtain a temporary identification by contacting Florida Department of Revenue @ 386-758-0420.

Vendors can begin setting up on Friday. We ask that vendors do not begin break-down until 6:00 p.m.
